- (13) That the society shall submit proposals for renewal of Provisional Recognition sufficiently in advance i.e., at least 6 months prior to the date of expiry of recognition.
- (14) The school management is requested to submit an affidavit every year with regard to non violation of rules / regulations prescribed by the Government from time to time.

(15) Economic strength should be maintained in all classes.

11. That the school shall not be closed without giving notice both to the parents/DEO and competent authority at least 6 months before.

12. That the school shall be closed or permitted to close only from the date on which summer vacation is declared.

13. That the society shall submit proposal for Renewal of Recognition sufficiently in advance i.e., at least 6 months prior to the date of

expiry of the renewal of recognition.

14. The recognition now given is purely on a temporary basis and is subject to the reports of State Level Inspection and Vigilance Committee fulfilling of all the prerequisite conditions under the A.P. Education Act, 1982 and if later found that the School has not fulfilled any prerequisites as stipulated, the recognition now being given is liable to be withdrawn at once.

15. The Management is requested to follow the instructions of the Fire Service Department and renewal the Fire Certificate from time to
